  - o This does not include site specific email, or domain registration
  - o Currently we use Gmail for a free shared "personal" account
  - o Domain Registration will renew on January 24, 2023, going up from \$47.70 to \$49.70
  - o Analytics Update:
    - 51 site session in the last month (+31%)
      - 78% new visitors (+19%)
      - 22% returning (+50%)
