

Oxbow-Masardis Snowmobile Club Meeting

Minutes 11/14/2023 Meeting began at 6:15 pm

President's Introduction & Report (Scott Soucy):

Trail Routes: Map of current trails reviewed. Names of trails agreed upon and placed on map. ITS 85 will be removed from the Church Trail and will be routed on the Jack Aikens Brook Road north to the junction that goes to Houlton Brook South. The trail from said junction to The Homestead and down to the River Road and access to the river will be 71-A. The River Trail, the Church Trail, the Farm Trail, the West End Trail and the Oak Hill Trail will be designated as local trails for multi-use to attract cross-country skiers, dog walkers, and slow moving snowmobiles.

Bridge Work: Scott headed up a team of volunteers to repair the St. Croix Bridge. They replaced 2x4s with lumber donated by the Daaquam mill. More extensive bridge repair will be needed in the next few years. Scott and Paul also repaired a bridge on ITS 86 near the St. Croix Road. Rubber mats were added to the bridge to help retain snow covering.

Seven Islands: Scott was in communication with Seven Islands and the Ashland Snowmobile Club. There is an administrative fee charged by Seven Island which the two clubs share. Ashland paid the fee this year and OMSC will pay the fee next year. The fee is \$250 this year and will increase to \$300 next year.

Drag and Groomer Maintenance: The Tucker was serviced when it went out for repair in the spring. Scott, Lenny and Martin will service the Pisten Bully in the next few weeks. Lenny will weld the broken cutter back onto the new drag and the drags will be fitted to be swapped to put the heavier drag on the PistenBully. We need lights for the back of the PistenBully and the new drag. George McPherson has a light bar he will donate. Scott is looking for the PistenBully Owners' Manual - please let us know if you have seen it.

Vice President & Project Director (Gary Currier):

Municipal grant: Grant has been submitted and a follow-up call will be made to Joe Higgins to ensure its receipt.

Signage update: Signs are on trailer at Currier Farm and are ready to go.
